- The Diversity Champion category is available to both male and female candidates and will be presented to professionals that serve as advocates for female advancement and catalysts for change and equality within the CRE industry.
- Each submission must include a professional headshot. The image must be in color, a minimum 300 dpi files and in .jpg format.
